Application are invited from eligible candidates for appointment of ONE Veterinary Doctor at Assam Rifle Dog Training Centre, Jorhat (Assam) on Contractual Basis as per the terms & conditions mentioned below :-

- Date & place of Interview**- Will be intimated to candidates by post & Telephone/e- mail.
- Remuneration** Rs 75,000/- (Rupees Seventy five thousand Only) per month
- Age** Not more than 67 yrs (Please also refer para 6 below)
- Educational & Professional Qualifications**  
(a) **B.V.Sc / M.V.Sc (Bachelors/Master of Veterinary Science and Animal Husbandry) from a recognised University and registration with Veterinary Council of India/State Veterinary Council.**
- Medical Examination** Immediately after interview on the same day candidates will be medically examined by Board of Medical Officers. Appointment will be subject to Physical Fitness.
- Period of Contract** The Contractual Appointment will be for 3 years or till regular incumbent joins or 67 years whichever is earlier. Thereafter, the contract will lapse automatically, However, the appointment can be terminated at any time by giving one month notice (on either side) without assigning any reasons by paying/ refunding one month salary.
- No Extension beyond the stipulated three years will be given.
